Vendor/Craft Expectations of Participants:

- + All vendors are responsible for collecting Kentucky sales tax and be responsible for all licenses and fees.
- + Duplicate Vendors will not be accepted. Registration is on a First come First serve basis.
- + Set up each night will be 4-6pm each night.
- + All 10x10 spots/booths will be marked and floor plan posted on concession door.
- + Vendors must supply electrical cords 50 or 100 foot & Tables.
- + NO tents will be allowed unless you are setting up outside the blue building. Few spots available without electric. All outdoor tents must be properly secured.
- + ALL merchandise must be new. Absolutely NO used clothing, yard sale material, etc....will be permitted.

- + NO FOOD VENDORS WILL HAVE TO HAVE PRE-APPROVAL FOR THIS EVENT DUE TO THE CARNIVAL AND CONCESSION STANDS.
- + Vendors are required to stay 6:00 pm – 10:00 pm the nights of your participation
- + All vendors will receive a Gate Pass to allow you in the gate AT NO CHARGE ONLY on the nights of your participation ONLY. **THIS WILL NOT ALLOW YOU INTO THE CARNIVAL. YOU MUST PURCHASE A TICKET IN ORDER TO RIDE CARNIVAL RIDES!**
- + **ABSOUTLEY NO REFUNDS WILL BE GIVEN AT NO SUCH TIME UNLESS THERE IS AN UNFORESEEN EMERGENCY.** The fair board will decide if there is cause for refund at the next available meeting typically held in August.
- + After unloading all vehicles/vans/trailers/of a vendor/crafter and their personal must be moved toward the parking area as directed by Jessamine County Fair Staff by 6pm on the night of setup.
- + Vendors are welcome to leave their booths set up if you are participating on a consecutive night only. Vendor must provide all tarps and or coverings if necessary for your products.
- + The Jessamine County Fair is not responsible for any lost or stolen items of the vendors products, supplies, or merchandise of said event.

Jessamine County Fair will provide

- = Electric to booths inside the blue building only
- = A gate pass for entrance to the park only for days of participation.
- = Restrooms are located inside Blue Building
- = The Blue building will be locked nightly at **10pm** to ensure protection of all participating vendors merchandise if participating consecutive nights. The Jessamine County Fair Board is not responsible for any lost or stolen items during or after hours of the Fair.
