Miss Preteen Jessamine County Fair Pageant

Tuesday, July 8th at 7:30 pm Age: 8-12

Parents/Guardians MUST read the contents of this RULES AND REGULATION page thoroughly. Parental/Guardian consent for contestants under 18 years MUST be obtained to register for the Pageant.

RULES AND REGULATIONS

- 1. This is an OPEN pageant. Open to all residents of the state of Kentucky.
- 2. ENTRY FEE- \$55.00
- 3. Contestants must be single, born a natural female, never been married, never had a marriage annulled and never had a child nor have a criminal record of any kind, (drugs alcohol & etc.)
- 4. They must not have won any other preliminary competition to the Miss Pre-Teen Kentucky County Fair Pageant. Previous queens of the Miss Pre-Teen Jessamine County Fair are not eligible to compete.
- 5. The contestant must be 8 years of age on June 30th and cannot be 13 on October 31st of the year when the local pageant is held at the local fair.
- 6. A copy of the birth certificate must be submitted with application. We will not accept a photo, email, screenshot or original being shown to us. We must have a copy of the birth certificate with the application for it to be considered submitted.
- 7. Contestants will appear in a Summer Dress/Romper for Introduction, Opening Outfit (same attire as Introduction), Evening Gown & On-Stage Interview.
- 8. Photo Contest (Optional) \$5/1 or \$10/3 4x6 size photos only. Categories include Most Photogenic, Prettiest Eyes, and Prettiest Smile. Only one 4x6 photo per category can be submitted. Print contestants name and category on the back of each 4x6 photo submitted. One winner per category will be chosen and receive a medallion. Photos will NOT be judged & money will NOT be refunded if you submit professional photos of any type, headshots, altered photos or any size photo other than a 4x6. Photos submitted will NOT be returned.
- 9. Dressing rooms will be open at 5pm. Dressing rooms have air conditioning, racks to hang your outfits, make-up area with mirrors to get ready & outlets for your hair accessories. Limited space available. First come, first serve. No reserved seating.
- 10. Only one designated person is allowed in the dressing room with each contestant while getting ready. No males allowed due to privacy issues. No running in & out of dressing rooms! Please respect the privacy of the contestants.
- 11. No cameras, video cameras, tablets or cell phones allowed in dressing rooms. This rule will be strongly enforced. If anyone is caught using a camera or cell phone, they will be confiscated and will result in disqualification from the pageant. This rule also applies to the designated person in the dressing room with the contestant.
- 12. Forms of payment: Certified Check, Money Order, or Cashier Check made out to Jessamine County Fair. Credit/Debit cards will be accepted on the pageant night.
- 13. You can go online to our website http://jessaminefair.org and download application, fill out and print or print and fill out.

- 14. Ways to Submit Application:
 - A) By mail
 - B) Drop Box
 - C) Signing up the night of the pageant.
 - A. <u>Sending by mail</u>: It must be postmarked by July 1st. Include the completed entry form, copy of contestant's birth certificate (state issued), photos (labeled correctly) if entering photo contest and correct form of payment.
 - You must arrive no later than 7pm the night of the pageant at the <u>registration table</u> to get your contestant number. No entries will be accepted after 7:15pm.
 - B. <u>Drop Box</u> will be found on the front porch of the mailing address. Applications can be placed into the drop box between 8am-8pm until Friday, July 5th. Make sure to include entry form, correct form of payment, copy of birth certificate, & 4x6 photos if entering photo contest in a sealed envelope labeled Miss Preteen Jessamine. There will be a folder labeled Miss Preteen Jessamine with applications if you need to fill one out.
 - You must arrive no later than 7pm the night of the pageant at the <u>registration table</u> to get your contestant number. No entries will be accepted after 7:15pm.
 - C. <u>Sign up for the night of the pageant</u>: Please bring the required paperwork, correct form of payment & 4x6 photos (labeled correctly) if entering photo contest. Applications will be available @ the <u>sign-up table</u>.
 - We will start taking sign-ups at 5:30pm no later than 7pm. No entries will be accepted after 7:15pm.
- 15. The winner will hold their title for a period of 1 (one) year and must be available to attend next year's pageant to crown the new winner.
- 16. The winner will receive a crown, sash, sash pin, award, ribbon, flowers & 1-night stay at the Crowne Plaza Hotel in Louisville at the state pageant in October. We will make the hotel reservation. It is the responsibility of the winning contestant or parent/guardian to buy their tickets online at www.kafs.net
- 17. 2nd & 3rd place will receive awards & ribbons. The winners of the photo contest will receive a medallion.
- 18. The winning contestant will represent Jessamine County in the Miss Pre-Teen Kentucky County Fair State Pageant to be held in October at The Crowne Plaza in Louisville. Any type of sporting event, competitions, or dances DO NOT take precedent over the state competition.
- 19. If the winning contestant is not able to participate in the state pageant, you must give at least 4 weeks' notice to the director by phone and a written statement by email. As to give the runner-up enough notice to compete. Failure to do so will result in forfeiture and the runner-up will assume the duties and responsibilities and receive all the awards.
- 20. It is at the sole discretion of the winning contestant or parent/guardian to have all the state paperwork submitted online by the end of July. A copy needs to be emailed to the director. All state information will be found under Beauty Pageants at www.kafs.net.. Failure to do so will result in forfeiture.
- 21. The contestants' name, age, complete address, telephone number, e-mail address must be correct on application.
- 22. Grounds for disqualification can be but not limited to untrue statements on registration forms, unruly behavior, misconduct, obscene or foul language in public or posted on any social media platforms or any other reasons the pageant committee may deem, as necessary.

- 23. If the pageant committee is harassed or untrue statements are placed online, on any social media platforms, websites or by any other means, it qualifies as an automatic disqualification from our pageant system entirely. And if anyone causes any problems, harassing the directors or judges will be escorted off the premises and re-entry not allowed.
- 24. If there are any problems you feel you need to bring to our attention or questions, please direct them to the pageant committee.
- 25. The Jessamine County Fair is not responsible for any accidents, injuries, or loss of property.
- 26. All decisions of the judges are final! NO REFUNDS! NO EXCEPTIONS!

(Make sure the gown is not too long where you are tripping over or too short where you can see shoes)

On Stage Interview: One age-appropriate question drawn at random from a basket.

JUDGES CRITERIA

Overall, the judges are looking for the girl they believe.

- Is confident, in control and gives intelligent responses.
 - Has positive body language and good eye contact
 - Can support opinions.
 - Is honest, sincere, spontaneous, and has a sense of humor.
 - Is well groomed and fashionable.
 - Is poised in interview and on stage.
 - Is Natural with an attractive smile, face, and hair.

During the <u>Opening Outfit Competition</u>, the judges are looking for physical fitness, natural beauty, poise, self-assurance, projection, showmanship, good eye contact, smile, and appropriateness of outfit.

During the Evening Gown Competition, the judges are looking for gracefulness in gown, natural beauty, poise,

Good eye contact, projection, self-assurance, overall presence, showmanship, smile and the fit and appropriateness of dress.

During the <u>On-Stage Interview</u>, the judges are looking for poise, good eye contact, personality, articulation, appropriate responses, intelligence, self-assurance, confidence, charm, and natural beauty.
