OPEN PAGEANT

RULES AND REGULATIONS FOR ALL CONTESTANTS

Parents/Guardians & Contestants MUST read the contents of these RULES AND REGULATIONS pages thoroughly. Parental/Guardian consent for contestants under 18 MUST be obtained to register for the pageant.

1. This is an OPEN PAGEANT. Open to all residents in the state of Kentucky.
2. The contestant must be a natural born female, single, never married, never pregnant and never had children, nor have a criminal record of any kind.
3. They must not have won any other preliminary competition to the Miss Kentucky County Fair Pageant. Previous queens of the Miss Jessamine County Fair Pageant are not eligible to compete.
4. Contestants must be 13 years of age on October 31st and cannot be 16th on October 31st of the year when the local pageant is held at the local fair by state guidelines {example: if you are 12 but turning 13 by October 31st you are to be eligible for the Teen pageant. If you are 15 years old but turning 16 years old by Oct. 31st you are to enter the Miss Jessamine Pageant}.
5. We must have a picture of the original birth certificate with application for it to be considered submit online at www.bombyhead.com
6. Entry Fee: \$65.00
7. Photo Contest (Optional) **\$10/1** or **\$30/3** - **Categories** include **Most Photogenic**. Submit professional photos of any type of headshots or any size on www.bombyhead.com
8. Forms of payment: Only online through www.bombyhead.com
9. Contestants will start with a personal interview with all the judges, then outfit of their choice for on stage introductions (can be the same outfit as interview) & evening gown.
10. Dressing rooms will be open at 9am. Dressing rooms have air conditioning, racks to hang your outfits, make-up area with countertop space with mirrors to get ready & outlets for your hair accessories. Males allowed in the styling area.
11. Only one designated person is allowed in the dressing room with each contestant while getting ready. No males allowed in the dressing room! Once the contestant is ready, the designated person needs to leave the dressing room until time for dress change. No running in & out of dressing rooms! Please respect the privacy of the contestants. No cameras or video cameras allowed in the dressing rooms.
12. The Winner will receive \$300.00 in Prize money, Crown, Sash and others with a two-night stay at the Crown Plaza in Louisville. We will make hotel reservations. It is the responsibility of the winning contestant or parent/guardian to buy their tickets online @ www.kafs.net

13. 2nd & 3rd place will receive an Award. The winners of the photo contest will receive a picture frame.
14. The winner will hold their title for a period of 1 (one) year. The winner must be available to attend the fair week and events July 6-11, 2026. They need to be available for local events within the community and parades. After completing their reign as Miss Teen Jessamine County Fair, they will receive their prize money when they crown the new winner at the Kentucky state pageant.
15. The winner will compete in the state Kentucky County Fair pageant in October of 2026 when the Teen Pageant is held.
16. Any type of sporting event, competitions, or dances DO NOT take precedent over the state competition. If you can NOT compete you forfeit your reign to the runner up.
17. If the winning contestant is not able to participate in the state pageant, you must give at least 4 weeks' notice to the directors by phone and a written statement by email. As to give the runner-up enough notice to compete. Failure to do so will result in forfeiture and the runner up will assume the duties and responsibilities and receive all awards.
18. It is the sole discretion of the winning contestant or parent/guardian to have all the state paperwork submitted online by the end of July. A copy needs to be emailed to the directors to pageants@jessaminefair.org All state information will be found under Beauty Pageants at www.kafs.net. Failure to do so will result in forfeiture.
19. The contestant agrees to not compete in any other pageant system that would prohibit the fulfillment of responsibilities through her reign as Teen Jessamine Co Fair.
20. The contestants name, age, complete address, telephone number, e-mail address must be correct on application.
21. Grounds for disqualification can be but not limited to untrue statements on registration forms, unruly behavior, misconduct, obscene or foul language in public or posted on any social media platforms or any other reasons the pageant committee may deem, as necessary.
22. Family friends, participants and anyone that causes any problems, harasses the directors or judges will be escorted off the premises and re-entry is not allowed.
23. If the pageant committee is harassed or untrue statements are placed online, on any social media platforms, websites or by any other means, the contestant will be disqualified from our pageant system entirely.
24. I agree that any photos or videos submitted or taken during the event may be used for advertising purposes on the website, print, or any social media platforms.
25. All decisions of the judges are final!

30. People's Choice voting will take place through www.bombyhead.com
31. Mrs. & Ms. will run consistently with others for introductions and evening gown. NO interviews prior to just one on stage question during evening gown.

32. The pageant day line up is : Pre-Teen, Teen, Miss, Ms., and Mrs. The day will begin with interviews for (Pre-Teen, Teen, Miss) and move directly into stage competition running consistily.

JUDGES CRITERIA

Overall, the judges are looking for the girl they believe

- Has positive body language and good eye contact
 - Is well groomed and fashionable
- Is Natural with an attractive smile, face, and hair
 - Is poised in interview and on stage
- Is confident, in control and gives intelligent responses
- Is honest, sincere, spontaneous, and has a sense of humor

On Stage introduction:20% The judges are looking for poise, personality, articulation, good eye contact, smile, confidence, charm, and natural beauty.

Evening Gown Competition:50% The judges are looking for gracefulness in gown, natural beauty, poise, good eye contact, smile, projection, self-assurance, overall presence, showmanship, appropriateness and fit of the evening gown.

Interview: 30 % The judges are looking for Poise, good eye contact, personality articulation, appropriate responses, intelligence, self-assurance, confidence, charm and natural beauty.
