RULES AND REGULATIONS FOR ALL CONTESTANTS

Parents/Guardians & Contestants Must Read the Contents of These Rules and Regulations Pages Thoroughly. Parental/Guardian Consent for Contestants Under 18 Must Be Obtained to Register for The Pageant.

1. Pageant is OPEN to all Kentucky residents.
2. Entry fee is \$50.00. Contestants will compete as a couple.
3. Contestants must have reached his/her 5th birthday and cannot have reached his/her 8th birthday by June 30th.
4. You must upload a picture of the original birth certificate onto www.bombyhead.com upon filing out your application.
5. Individual Photo Contest (not as couples) (Optional) \$10/1 or \$30/3 uploaded to www.bombyhead.com categories include Most Photogenic.
6. One winner per category for girls & the same for boys will be chosen and will receive an award.
7. Contestants will be judged as a couple on poise, natural beauty (no make-up allowed), personality, and their presence & natural responses during their on-stage interview.
8. No Make-Up
9. Wardrobe: Contestants will wear blue jean shorts (no holes in them), solid color tops, & sandals or white tennis shoes. They can wear any style or color of belts or hair accessories. Absolutely no other style of outfit is permitted.
10. Winners will receive the following: crown, sash, awards and flowers. 2nd & 3rd will receive an award.
11. Winners will represent the Jessamine County Fair in August, the opening day of the state fair in Louisville at the Little Miss & Mr. Kentucky County Fair State Pageant.
12. Applicants will apply on www.bombyhead.com or you can find the link to apply at jessaminefair.org.
13. **You can no longer sign up on the day of the pageant!** You must have an online application submitted thru www.bombyhead.com the Sunday prior to the Jessamine County Fair.
14. Visit the Kentucky County Fair State website @ www.kafs.net for more information on the state.
15. pageant. State paperwork must be submitted within 2 weeks from pageant date and a copy sent.
16. to the director by email pageants@jessaminefair.org . Not submitting the state paperwork within the required time period is grounds for disqualification.
17. If the winning contestant is not able to participate in the state pageant, you must give at least 2weeks' notice to the director by phone or email. As to give the runner-up enough

notice to compete. Failure to do so will result in forfeiture and the runner-up will assume the duties and responsibilities.

18. Only one designated person per contestant is allowed in the dressing rooms. There will need to be one designated adult with the girl contestant in Dressing Rm A & one designated adult with the boy contestant in Dressing Rm B while getting ready. No running in & out of dressing rooms! Please respect the privacy of the contestants.
19. No cameras, video cameras, tablets or cell phones allowed in dressing rooms.
20. Grounds for disqualification can be but not limited to untrue statements on registration forms, unruly behavior, misconduct, obscene or foul language in public at the Fair.
21. Anyone that causes any problems, harasses the directors or judges will be escorted off the premises and re-entry is not allowed.
22. The Jessamine County Fair is not responsible for any accidents, injury, or loss of individual property.
23. The judge's decision will be final. No refunds! No Exceptions!

25. This pageant will begin directly after the Beauty & Stars Pageant at 6:00pm.
